**Funding Purposes** Listed below are examples of specific community program planning activities and expenditures for which the requested Prevention and Early Intervention (PEI) funding will be used. The first year's planning activities focused on engaging stakeholders from all segments of the community and through that process, identifying community needs. This year's activities are directed towards identifying, engaging and analyzing community and county resources to meet those needs.

- I. Preparation for Program Implementation: Activities and expenditures anticipated include:
  - Continue analysis of data from various service sectors in order to assess current community capacity and resources.
  - Continue to equip new PEI staff with all necessary technology (cellular telephones, computer hardware and software, etc.) to coordinate planning activities for PEI and the cost of enhanced and/or increased space needs for these employees.
  - County resources and/or consultants to assist in evaluating, summarizing and disseminating information on PEI strategies, resources and needs.
- II. Focus Groups and Stakeholder Meetings: Activities and expenditures anticipated in order to maximize the contributions of strategic service sectors and stakeholders to the PEI planning process include:
  - Continue meetings, conference calls, dissemination of information and announcements through electronic and print media, focus groups, interpreter services, document translations, interviews, and other methods to be used to present the DMH proposed guidelines to stakeholders.
  - Continue consultations with key informants; convening and obtaining input from focus groups.
  - Continue support to County resources and/or consultants to assist in facilitating stakeholder meetings and focus groups.

# III. Other Community Program Planning Expenditures

- County resources to facilitate and conduct planning activities, and recruit and train personnel for the proposed PEI programs and services.
- County resources to prepare for contracting with PEI providers including the development of Request for Proposals and establishing contracts.
